SECRETARY'S REPORT

CURATOR'S REPORT

Rudy took home a child's steamshovel and refinished it so it looks like new. She reported this summer, 4 cook books, 2 diamond jubilee plates and 3 diamond jubilee books were sold. She also advised we are getting between 2 and 4 people visiting the museum on Sundays. Motion was made by Clare, seconded by Ken to accept the Curator's Report as presented. Motion Carried.

OLD BUSINESS;

- 1. Election- President Schnaitmann advised we had our election in April and the installation banquet in May and he feels confident the members that were elected, will work with him to have another successful year. The installation banquet was a huge success. Those who were in charge of it did a great job. He also would like to thank the park district for the fine buffet. The food was excellent.
- 2. Furniture Refinishing- President Schnaitmann advised the two chairs used at Lollipop Lane have been refurbished and are located at this time in the downstairs of the Carriage House. He also noted the roll top desk is still being refinished. The gentleman advised many parts have to replaced and he is hoping to get the locks working properly. He will make deliverly when finished.

NEW BUSINESS:

- 1. Storage Boxes- Curator Knippen advised special storage boxes are needed for clothing. Lorraine Haben advised she talked to Tony Alteri and he remembers getting some from another society who were overstocked. He suggested we contact other societys.
- 2. Autumn Fest President Schnaitmann advised the annual Autumn Fest put on by the park district will be held October 7, 1995. He received a letter from Trudy of the park requesting the society to take part in this annual event and have the museum and carriage house open. He left a message for her that the society would do so. Commission Klumpp advise she also had talked with Trudy and said if the society needed any assistance or supplies, to let them know. President Schnaitmann advised that time will be from 12 -3 p.m., and anyone from the society wishing to volunteer, is needed and welcome.

It was also noted Sam's cars will be located at the carriage house. Rudy mentioned signs will be needed. Commissioner Klumpp said a list of what is needed should be made and given to Trudy.

Discussion ensued regarding signage advising of the location of the museum in Wheeling is still needed. It was noted IDOT has to be contacted and they are the ones to make the decision.

4. Lollipop Lane-Lonnie reported Lollipop Lane will be held December 9th through the 17th. Set up time will be the week of the 4th through the 8th. Times open on Saturday and Sunday are 2 - 5 p.m., weekdays 6:30-8:30 p.m. Lonnie suggested a "sports" tree be added this year. Discussion. It was agreed that about 15 sets of lights are needed. Dolly requested a list of what is needed be made and given to her and she will have a complete budget before next month.

4. Handouts-Lonnie reported she has checked into getting magnets with the Wheeling Historical Society logo and phone number to be given away at the museum. She noted the price for 500 is \$140-\$150. Discussion ensued. Motion was made by Sue, seconded by Ken to approved the purchase of 500 magnets. Motion Carried.

It was noted the refreshments this evening were provided by Lorraine and Sue. Next month Lonnie and Dolly will be hosts. President Schnaitmann advised anyone wishing to pay their memberbership fee is welcome to do so at this time.

Commissioner Klumpp introduced herself and advised she is the liaison to the historical society. She advised she would not be at the next meeting but Commissioner Melamed would be present.

APPROVAL OF MINUTES

She noted there is a group of people that wish to save some one hundred old cottonwood trees behind Whitman School. Discussion ensued. The membership advised they did not want to get involved regarding the trees.

It was advised that a gentleman has a thousand bricks from the Union Hotel which was just torn down and wants to know if the Historical Society would be interested in selling the bricks with him. Bob asked to what benefit this would be to the historical society? - 3. Autumnfest For those who did not attend, President schnaitmann advised the park presented its Autumnfest and it was a success in spite of the weather. Many people attended the museum. Rudy did a good job at the Carriage House showing how the corn husker worked.
- 4. Computer- Dolly stated she was told by Sue that a proposal to purchase a computer for the museum has been given to Tom Busby of the park district for review and he will get back to her.

5. Magnetic Tags- Lonnie presented the artwork of what the tags would look like. She advised we will get 500 of them for distribution.

NEW BUSINESS;

- 1. Museum Christmas Budget President Schnaitmann advised the membership, the board disccussed the budget for both the museum and Lollipop Lane and is recommending a budget of \$100 for the museum and \$300 for Lollipop Lane. The \$300 will cover the items other than the new trees and lights as they were big items. Motion was made by Eleanor, seconded by Clare that a Christmas Museum Budget for \$100.00 be approved. Motion Carried.

She stated the trees and lights have already been paid for and it is her feelings that next year the expenses for Lollipop Lane will be at a minimum. REFRESHMENTS:



OLD BUSINESS:

1. Lollipop Lane- Lonnie gave her report regarding Lollipop Lane. She noted she is handing in receipts for \$300.00 which was given to her and is returning \$27.10 of that amount. She advised next year we will need more lights and more decorations for the sports tree. She asked if anyone runs across anything this summer appropriate for the sports tree and is reasonable, please pick it up and they will be reimbursed. Discussion ensued. She thanked all members who helped either by cookies and/or setting up and taking down of Lollipop Lane. Extra thanks goes to park maintenance men for all their help. He talked about the growth of the village and school district and the floods when they used ducks (army vehicles) to pick up the kids for school. He also talked when they introduced a program and they brought blind children into the school system. He mentioned Jack Norse, School District #21's first Superintendent and Mr.Ken Gill who was Superintendent of School District #21 for twenty one years, Carl Holstrom who followed and Mr. Buz DeCarpentre who is presently Super-intendent. Following his talk, the membership was given time to look at the scrapbooks, records from 1939, etc. In all, it was a very interesting evening. The membership thanked Mr. Kiffel for his time.

REFRESHMENTS:



MINUTES OF THE MEETING OF THE WHEELING HISTORICAL SOCIETY OF September 23, 1998

The meeting of the Wheeling Historical Society was held on September 23,1998 and was called to order at 7:38 p.m., by President Haben at the Wheeling Community Center, 251 North Wolf Road, Wheeling, Illinois 60090.

PLEDGE OF ALLEGIANCE:

The pledge of allegiance was led by the President. There were eighteen members in attendance. In the absence of Liaison Commissioner Klumpp, Vice President Webber of the Park District was in attendance. Guest present was Dr. Tom Shirley former Principal of Wheeling High School.

APPROVAL OF MINUTES:

The minutes of the meeting of April 22, 1998 and the notes from the May banquet were submitted for approval. Motion was made by Treasurer Hein, seconded by Curator Reading to approve the minutes and notes as presented. Motion Carried by Voice Vote.

TREASURER'S REPORT:

The Treasurer's Report was read in full. She advised the report was from the preceding year. She explained in detail the income and expenditures for the preceding year from May to September. She noted much of the expenses were for artifacts, post office box, stamps, dry cleaning of vintage clothing, our banquet, dues to the Il. Historical Society, etc; which totaled \$1,412.82. \$400 was transferred from the Money Market with the approval of the Board, to help pay for the 4th of July float and with dues and donations, a total deposit of \$1,170.83 ending up with a bank balance in the checking account as of now is \$95.17. She noted the amount in the money market and asked if there were any questions, she would be happy to answer. There being none, motion was made by Elaine Simpson, seconded by Eleanor Buerger to approved the Treasurer's Report as presented. Motion carried by Voice Vote.

President Haben advised the membership with the opening of Vice President since the death of Bob Buerger and we do miss him, Elaine Simpson has agreed to be our appointed Vice President to finish out the term for 1998-1999 year. She took her seat. President Haben announced Rudy Horcher has been appointed Assistant Curator of the Carriage House.

CURATOR'S REPORT:

Linda advised her report was included on the back of the newsletter. She noted the research projects within the report. These were some of the people who contacted her over the summer and she was able to get some information back to them. She also is requesting any member who has some of the information requested, to please let her know. She explained some of the other activities she has been involved in. Frank Schnaitmann commended Linda, Patti and Dolly on the museum. Linda also advised the park district has been working at the museum in replacing the ceiling and fixtures in the kitchen area and also in December they will start the renovation in the basement. She noted we may need volunteers to help pack before the renovation.

OLD BUSINESS:

- I. Installation Banquet- Lorraine advised it was alot of fun this year and as usual the food was very good and Marvelous Marv entertained us all and we intertained ourselves because we all had a chance to sing. She hopes next year it will be as good.
- 2. 4th of July Update- President Haben advised we had a very nice float with some of us on it dressed in period costumes. Also we had a very successful parade. She is hoping that maybe next year we can make our own float We were a little disappointed this year because there weren't chairs on the float and Irene and Sam who are our oldest members, could not participate because they could not sit. She noted those who participated has a little trouble holding on.

President Haben noted our new Vice President will also be on the Committee of Public Relations. We do have to get more publicity.

COMMITTEE REPORTS:

She called on the Membership Chairman, Frank Schnaitmann and he advised the members if there was anyone who has not paid their dues yet, they are due now. We would like to get our membership list updated. He verified a few of the names with members present.

President Haben advised that Lonnie Schnaitmann is our Social Chairperson who is ill this evening and will not be present. Eleanor and Irene are serving this evening. She questioned is anyone volunteered to serve at the October meeting and stated she would volunteer. Barb Forke volunteered also.

President Haben advised that Donna Nystrom is also on the Publicity Committee. She questioned Donna and Elaine if they had plans for the October meeting? Elaine said they were planning to have someone give us a presentation on Riverview Park but due to the fact it was such short notice, we could not get them for October, but she thought it might be a good time to do some brainstorming on how to raise our membership and ways of doing it. She asked anyone with ideas, please bring them to the October meeting so they can be discussed.

President Haben stated that at the Board meeting discussion was held about signage for the Historical Museum. She turned this over to Donna who stated she had talked to someone who would make us a sign for our needs. Lorraine noted we would have to get permission. Discussion ensued.

President Haben advised as far as the Program Committee goes, no one was appointed as the Board felt they would try to come up with some interesting programs.

President Haben asked Vice President Webber about the Autumnfest which will be coming up at the park district. It will be held Sunday the 27th from 1 to 4:00 p.m. Discussion ensued. It was noted this is usually held on a Saturday but Mr. Webber said he would make a call and let us know for sure. Lorraine advised the museum will be open in case anyone comes. Discussion ensued relative to the moving of the Autumnfest from Chamber Park to Heritage Park. It was noted the possibility of the park holding something in spring at Chamber Park which would include the Historical Society.

Mr. Webber stated mother nature has really been kind to the park district as they had a tremendous season at the aquatic facility which handled about 95,000 patrons during the summer. Chevy Chase golf course also had a great season.

Mr. Webber updated the membership relative to the Park District's renovation of Chevy Chase Clubhouse. He stated the bids came in and they were reasonable although they would liked to have seen them a little lower. They will be issuing contracts within the next few weeks and demolition will begin on the south side of the building (Gaable Room), probably around the 20th of October. The holiday season is drawing near and we're ready to accommodate all those patrons. He advised after the first of the year the building will be closed and work will be done on the Wayside and Devonshire rooms. He noted that the rooms south of the main ballroom will be unrecognizable. The ballroom will be updated and preserved as it is today. They anticipate reopening the first week of December 1999.

In reference to the Recreation Center, bids were opened for the new swiming pool and an expanded fitness center on the main floor. He noted the bids that came in, the park board was very pleased with them although a final decision has not been made yet. Discussion ensued.

Mr. Webber advised a community wide survey will be going out within the next six weeks which will be similar to what was sent out about eight years ago, the only difference is, it is not for any type of referendum but for input from the residents of the community.

Linda asked Tom to tell the membership about the new signs the park will be puting up. He advised the park is in the process of renovating Pheasant Run Park which is in the south end of our district and they have received a grant of matching funds from the State of Illinois. He stated they are working with the Prospect Height Park District and it is the first time there has ever been two communities coming together in a venture on a grant proposal. He advised they will be puting new signs at all of the parks which will have the park district logo and will tie in with the Historical Society at this location. Frank asked when puting in the new signs if they could be placed so they are seen from the north and south when driving by. Tom felt they would be double sided signs which would be visible from north and south.

Mr. Webber hopes for completion by next June. Discussion ensued. The Society thanked Tom Webber for attending the meeting and for the information he shared with us.

NEW BUSINESS:

President Haben advised it was discussed at the Board meeting to provide a budget for the curator. It ws felt the curator should have the authority to purchase an artifact she feels will enhance the museum at the time she finds one. Discussion ensued. She noted different amounts were given and it is her opinion as a member that the amount be the same as that which is given to Lollipop Lane. Treasurer Hein advised that much of the monies to cover the cost of Lollipop Lane is provided by donations received from letters sent out to different organizations. Rudy Horcher suggested that \$500.00 be put in the kitty and that is to be used for the purchase of artifacts. Treasurer Hein advised the other society's hold fund raisers for this purpose. Lorraine advised we do need to have fund raisers and this should be given some thought. Following lengthly discussion, motion was made by Frank Schnaitmann, seconded by Eleanor Buerger that at this time a budget of \$100.00 be given to the curator so she has some money to work with and to be further reviewed by the Board at their next meeting if they want to increase the amount. Motion carried by Voice Vote.

President Haben advised she has received a packet of pictures from Peggy Kruse when her father owned Wheeling Nursery which was then, the Rose Garden. This is part of our history which is not there any more. Lorraine noted she would turn these over to the museum to be put into a booklet. A thankyou letter has been sent.

Linda advised she has taken pictures of the Circle Inn M and Braurer's property which will soon change. Lorraine also mentioned the Forke house will be torn down for a new parking lot. Rudy advised there are several graves in the cememtery which have no markers. He stated he could get markers for nothing and he would like to get the historical group and other organizations to hold a dedication and ceremony to commerate the men who died in the civil war. He noted the cemetery, especially the veterans grave do need attention. Lorraine felt this too is important and should be given consideration.

President Haben stated in conclusion to the regular meeting, she would like to turn this evenings program over to Dr. Tom Shirley who was the principal of Wheeling High School for many years and they have presented the Historical Society with a mural which has been placed in the museum but brought over this evening for Dr. Shirley to explain. It was thought this was done by a student dispicting 25 years of the existance of Wheeling High School.

Dr. Shirley thanked the society for inviting him. He advised the members he forgot his notes. He mentioned he did not know that Bob Buerger passed away and conveyed his condolances to Eleanor. He noted he and Bob spent time together. He gave thanks to Nancy Nelson of Wheeling High School for saving the mural because somehow there are people who don't have the sense of wanting to preserve history. This mural was on it's way to the garbage can and Nancy knew what this all means and rescued the mural and made arrangements with the society to bring it to the museum.

He noted there was some history he would like to talk about and that has to do with Wheeling High School and why the high school is here where it is on the 40 acres and why it was named Wheeling High School. You have to thank one of our former Presidents which is Russell McIntyre. He is the person who stood up and demanded the building be named Wheeling High School. The only thing was that it wasn't being built in the village. So Mac got what is call "Point established. This has not been used very much Contingency" in the State of Illinois. Of that 40 acres, there is a point in the middle of Route 83 which hooked it to Wheeling. that point got that area and the Wheeling High School in the Village of Wheeling. The mural was done in about 1987 at which time they commissioned Ed Fisher and art teacher and administrator in District #214 to do a collage of Wheeling High School. It was not part of the 25th anniversary but it was really part of our celebration of having achieved National recognition as the "School of Excellence" from the United States Office of Education. He stated Wheeling High School was the first school in District #214 get this honor and we wanted something special to mark that occasion. noted if you look around the picture, you will see the different kind of young people depicted. It fits the ethic mix that was and is present at Wheeling High School.

At one time 40 some different nationalities were represented at Wheeling High School. We always prided ourselves on this. Depicted in the picture is the Wheeling Band, football, basketball, orchastra, ROTC, Science Lab, Wildcat, the Madrical Singers and the Homecoming Queen along with others. The artist took alot of the back issues of the year books and pulled out things which would become memorabilia for the school as a whole.

Dr. Shirley presented the society with a smaller verson and print of the mural. He noted the artist is now deceased.

Dr. Shirley also brought along some books to show the period of time when the mural was made and the receiving of the award.

He also gave the Society a scrap book on the Family Fair made up by the Community Council which was active in 1962-63. He also stated he had other artifacts in his basement which he will give to the society for preservation. He noted the first Family Fair was held at Wheeling High School the first year the school was open and they had a flower arranging contest. He can still remember Doctor Taylor standing by the bouquet of wild flowers he picked out in the forest preserve with which he won the contest! Discussion ensued. The Society thanked Dr. Shirley for his presentation.

POT O GOLD:

The Pot O Gold was won by Marilyn Cromy.

REFRESHMENTS:

Refreshments were provided by Irene and Eleanor.

ADJOURNMENT:

There being no further business to come before the membership, motion was made by Pat Hancock, seconded by Marge Allison to adjourn the meeting at 9:10 p.m. Motion carried by Voice Vote.

MINUTES OF THE MEETING OF THE WHEELING HISTORICAL SOCIETY OF October 28, 1998

The meeting of the Wheeling Historical Society was held on October 28, 1998 and was called to order at 7:35 p.m., by President Haben at the Wheeling Community Center, 251 North Wolf Road, Wheeling, Illinois 60090.

PLEDGE OF ALLEGIANCE:

The pledge of allegiance was led by the President. There were eighteen members in attendance. Commissioner Klumpp, Liaison of the Park District was in attendance.

APPROVAL OF MINUTES:

The minutes of the meeting of September 23, 1998 were submitted for approval. Motion was made by Lonnie, seconded by Eleanor Buerger to approve the minutes as presented. Motion Carried by Voice Vote.

TREASURER'S REPORT:

The Treasurer's Report was read in full. She stated the balance in the checking account as of September 23, 1998, is \$95.17. She has transferred \$637.93 from the Money Market Account. The \$95.17 plus the \$637.93 and the \$43.00 received from the sale of cook books and Jubilee books gives a total deposit of \$776.10. Disbursements were as follows: 4th of July float of \$450.00, Curator for artifact budget \$100.00, totaling \$550.00. The Checking Account balance as of this date is \$226.10. CURATOR'S REPORT:

Linda advised most of her report was included in the newsletter. She noted the archiology exhibit has now been replaced by the Post Office Exhibit. The Web-Site has also been updated. A group of Girl Scouts will be touring the museum on Friday, October 30th. Anyone willing to help, please notify her. She also presented two sign up sheets

- 1. Curator Budget Pending- As agreed at the previous meeting, the Curator is given a budget of \$100.00 for the purchase of artifacts. If there is an artifact in a higher dollar amount, she will come before the board for a vote.
- 2. Signs In the absence of Donna Nystrom, President Haben advised we would like to have two signs made up indicating "Wheeling Historical Museum." She noted we will check with Jiffy Lube and White Hen to see if they will allow signs to be placed on their property.

NEW BUSINESS:

1. Lollipop Lane- Lonnie advised we will start to set up for Lollipop Lane November 30 - December 4th. run from December 5 through December 13th. Hours are Weekdays from 6:30-8.30 p.m. and Weekends 2 - 5:00 p.m. Irene and Shirley will take care of the calls regarding baking cookies to be sold at Lollipop Lane. Posters and fliers will need to be made. She asked that this year be dedicated to the memory of Bob Buerger, who was truly a real Santa. She requested a budget of \$500.00 to cover the cost of new decoratons and items being replaced. Motion was made by Grace, seconded by Linda a budget of \$500.00 be given. Motion carried by VOICE VOTE. Lonnie advised A parade will be held as usual and she is looking for any sports ornaments for the sports tree. It was decided the november program will be lent to making deer food to give away at Lollipop Lane.

- 2. Change of November Meeting Date President Haben advised because of the Thanksgiving holiday, the November meeting will be moved to November 18, 1998 at 7:30 p.m. and the Board meeting will be moved back to November 11, 1998, 7:00 p.m.
- 3. Constitution and By-Laws President Haben advised the membership the Rules and Revisions Committee (President and Board are updating and amending the Constitution and By-Laws. When finished they will be presented to the membership for approval.

President Haben asked if Commissioner Klumpp had anything from the Park? Cheri apologized for her absence but commended Vice President Webber for the information he made available to the Historical Society.

Cheri advised hopefully at the next meeting on Tuesday night, the contractors will be chosen for some of the trades and work can begin on the Chevy Chase renovation. Also the park district will go ahead with the addition to the recreation center and taxes will not be raised because of this project. It was agreed that no programs would be given in which an admission charge would be made, but Dolly Hein mentioned to have members bring a guest to a meeting and give a presentation to try to interest them in to joining the society. It was noted that publicity should be given to the news papers. The committee stated they would take all ideas into consideration.

There being no further business to come before the membership, motion was made by Frank Schnaitmann, seconded by Ken Kostrezewski to adjourn the meeting at 8:40 p.m. Motion carried by Voice Vote.

MINUTES OF THE MEETING OF THE WHEELING HISTORICAL SOCIETY OF NOVEMBER 18,1998

The meeting of the Wheeling Historical Society was held on November 18,1998 and was called to order at 7:40 p.m., by President Haben at the Wheeling Community Center, 251 North Wolf Road, Wheeling, Illinois 60090.

PLEDGE OF ALLEGIANCE:

The pledge of allegiance was led by the President. There were ten members in attendance. Commissioner Klumpp, Liaison of the Park District was also present.

APPROVAL OF MINUTES:

The minutes of the meeting of October 28, 1998 were submitted for approval. Motion was made by Dolly, seconded by Donna Nystrom to approve the minutes as presented. Motion Carried by Voice Vote.

TREASURER'S REPORT:

The Treasurer's Report was read in full. Treasurer Hein stated the balance as of October 28th 1998 was \$226.10. \$500.00 was transferred from the Money Market to cover expenses for Lollipop Lane. \$31.00 was received for membership dues which brought the balance to \$757.10. - 2. Social Committee- Lonnie noted she would need someone to serve in January. Patti and Dolly volunteered. February is pot luck. Donna and Linda said they would serve in March. Lorraine advised Elaine Simpson donated all the gifts on the table for the Pot-O-Gold.
- 3. Program The program for the evening will be making raindeer food for Lollipop Lane.
- 4. Liaison Report Commissioner Klumpp advised at the Wheeling Park District meeting Dolly, Patti and Wedge were in attendance. Dolly gave a nice little speech thanking the planning and maintenance people for all their help to the society. She also noted Dolly was there as always for Lollipop Lane and requested a \$300.00 donation be given this year. The board agreed. Cheri commended Dolly on a great job.

Lorraine also stated the maintenance men have been working at the chapel for two weeks putting on a new ceiling of the library which was destroyed by racoons. They seemed very appreciative of compliments given them. Today she was bugging the painters at the museum. It was her feelings that the commradery between the society, the park board and the maintenance crew has been terrific.

There being no further business to come before the membership, motion was made by Linda Reading, seconded by Dolly Hein to adjourn the meeting at 8:40 p.m. Motion carried by Voice Vote.
