MINUTES OF THE MEETING OF THE  
WHEELING HISTORICAL SOCIETY  
OF SEPTEMBER 25, 1996

In the absence of President Schnaitmann, the meeting of the Wheeling Historical Society held on September 25, 1996 was called to order at 7:35 p.m. by Vice President Buerger at the Wheeling Community Center, 251 N. Wolf Road, Wheeling, Illinois 60090.

PLEDGE OF ALLEGIANCE

The pledge of allegiance was led by the Vice President. There were twelve members in attendance. Also in attendance was Commissioner Klumpp, liaison for the park district. Vice President Buerger advised Frank has an infection and is on antibiotics at this time.

APPROVAL OF MINUTES

The minutes of the meetings of April 24th and May 22, 1996 were submitted for approval. Vice President advised they had not been mailed out for the members review. Motion was made by Don, seconded by Marge to table the minutes until the next meeting. Motion Carried.

TREASURER'S REPORT

Treasurer Hein reported on the installation dinner. She advised some members signed up for the dinner (reservations were made, but they did not show nor did they pay).
