The meeting was called to order at (8 P.M.) by the President; Shirley Mueller with (13) members present and The Wheeling Park District President; Lorraine Lark; The Superintendent; Dave Phillips and (3) Commissioners; Robert Ross; Hugh Wilson; Mr Schneiden

John Koeppen medended this Motion which carried unanimously.

A letter from our Museum Director; Glen Benson stating he is submitting his resignation as our Director/but will maintain his membership with us.

Lorraine Lark made a Motion to accept his resignation and in recognation of his work for us be given a Placque designating his sppreciation for his work to our Society. Bob Buerger seconded this Motion which carried.

A letter from The Lake County, Illinois Historical Society announcing their Dedication of a new Museum.

A letter from The Oak Park Society announcing the dates for the Loyd Wright home tours.

One from The Jim Campbell Band thanking our Society for the privilege of serving at our Brat N' Beer Fest again and that they are looking forward to the next year's affair in (1977).

A copy of letter addressed to Chief Marvin Horcher from the Research assisstant of The Chicago Art Institute of the Painting and Scuppture department mentioning his delight in the Chief showing him around Childerly and his interest in the research of their painting.

One from the Community association chairman of our are of The Northwest Girl Scout Council of Cook County expressing their desire to serve us at any time. (Betsy Altman), chairman

June Orlowski our Curator suggested a membership Booth for our next year's Brat N' Beer Fest to encourage new members. She also said that it is important to keep the Museum open at the designated hours and those interested should sign up tonight on the Calendar to Mann.

Shirley Mueller our President told us she had met with The Wheeling Park District Board to go over our agreements and came to the final document of same kind of interest on both sides. That she with The commissioners checked the Museum on Milwaukee Avenue. Her announcement evolved into the expression and opinion of Mr Ross, a commissioner expressing who spoke of the building and grounds. Explaining his plans and recommendations for an annexation after it hasbeen moved. That the building measures (30x25ft) with a (4000 sq ft basement space). That they plan to move this Fall to the Chamber Park on North Wolf Road. He also explained that the building would be too small for future expansion.

Lorraine Lark President of The Park District spoke and told us of her contact with The Calvert Foundation Association of The University of Chicago. The agreement was signed to-night of September 22, 1976 in the presence of (13) members of The Wheeling Historical Society and The Wheeling Park District Board.

## AGREEMENT BY AND BETWEEN WHEELING PARK DISTRICT AND WHEELING HISTORICAL SOCIETY

THIS AGREEMENT made this \_7th \_\_day of \_\_October \_\_\_\_\_\_, 1976, by and between WHEELING PARK DISTRICT, Cook and Lake Counties, Illinois, (referred to herein as "Park District"), an Illinois unit of local government, and WHEELING HISTORICAL SOCIETY, Cook County, Illinois, (referred to herein as "Society"), an Illinois not-for-profit corporation.

## WITNESSETH:

WHEREAS, Society has determined that it is in the best interests of the residents of the Village of Wheeling to preserve those historical artifacts which would be of lasting benefit to the residents of the Village of Wheeling; and,

WHEREAS, Park District has determined that it is in the best interests of the residents of the Wheeling Park District that certain premises located within the boundaries of the Park District be designated and operated as museums pursuant to the authority conferred by Section 8-3 and 326 of the Park District Code; and

WHEREAS, under and by virtue of Section 10 of Article VII of the Illinois Constitution of 1970, local government units within the State of Illinois are authorized to enter into Interlocal Agreements providing, among other things, for the exercise, combination or transfer of any power or function in any manner not prohibited by law or ordinance, and for the use of their credit, revenues, and other resources to pay costs related to intergovernmental activities; and

WHEREAS, the Park District desires to provide for the payment annually from the general revenues of the Park District of the cost of maintaining the museum properties, including but not limited to, the cost of all repairs, utilities, services, insurance on the structures (including contents), and custodial services.

NOW, THEREFORE, in consideration of the mutual convenants and agreements hereinafter set forth, the parties hereto do agree as follows:

### Section 1: Park District agrees:

- (a) That it will acquire and maintain park district buildings and facilities of historical significance for use by the general public.
- (b) That it will appropriate and levy needed funds for the operation and maintenance of sites which have been designated as museums.
- (c) That it will, with Society approval, retain a Director, whose duties will be determined by the Liaison Board.

#### Section 2: Society agrees:

- (a) That it will continue to raise funds to assist in the payment of expenses of the Society and will prepare and submit for approval to Park District's Board of Commissioners a budget for the fiscal year, May 1, to April 30.
- (b) That it will provide the expertise necessary in determining buildings and historical material to be acquired by Park District and Society.
- (c) That it will transfer title to Park District, those items of personal property set forth in exhibit A attached hereto and made part thereof.

## Section 3: It is further agreed as follows:

(a) A Liaison Board will bε appointed consisting of: (1) a member

of Society Board of Directors; (2) Society Curator. (3) a Commissioner of Park District; (4) Superintendent of Park District; (5) a member of community acceptable to above mentioned members.

The four members representing the parties hereto shall be appointed by the governing boards of each of the parties hereto within 60 days of the execution of this agreement. The fifth member shall be appointed at the first meeting of the Liaison Board. The Board shall have the authority to choose a chairman and secretary and set times for meetings (which shall not be held less than quarterly during each calendar year.)

The Liaison Board shall develop and recommend to Park District and Society Boards policies to be adopted pertaining to the implementation of this agreement, which when approved by Park District shall be the policies governing the Liaison Board.

Section 4: The terms of this Agreement may be altered or amended, by the consent of the parties hereto.

IN WITNESS WHEREOF the parties hereto have caused this Agreement to be executed by their proper officers duly authorized to execute the same.

New balance \$2138.48.
- BRAT & BEER The President thanked members for working so diligently at the Brat & Beer Festival. He said it was a success and that advice of results would be forthcoming from Park District. Doris Kerr made a motion that the Society's profits of the Brat & Beer be allocated to the Childerley Fund. Cris Irmiter seconded. Motion passed -- funds will be so allocated. Dorothy Foentge claimed the monies counted from the Brat & Beer before expenses exceeded \$9000. The function would be held outside before a blazing fire if weather permitted. Christmas carols were sung and the schools worked with the Chamber. There was skating on the river, burning of the trees, ice making, the traveling butchers, and bakery trucks, and also nostalgic memories of the peat marsh under Wolf Road.

President Burger asked if there was any other business or question. G. Kavanagh asked if Wheeling would provide a sign indicating location of the Wheeling Historical Museum. She said that Buffalo Grove has one posted on Dundee Road.

There was no further business. L. Lark made a motion to adjourn. G. Kavanagh seconded. Motion passed by voice vote.

- 2. Mrs. Klocke felt (a) there are too many people in each Committee and (b) the committees are too inactive.

  Mr. Benson asked to define comment 'b' because he felt it is difficult to raise monies which unhappily causes 'b' to appear inactive. Mrs. Klocke countered with the fact that the Society is a non-profit group, and upkeeping historical artifacts. Mr. Benson said this cannot be done without funds. Mr. Benson felt he would prefer preparing historical and sight-seeing trips for the Society, but that also, involves money. Discussion ensued. President Buerger asked Mr. Balling if he would prepare a talk for the Installation Dinner. Mr. Balling agreed.

If there was no further business or discussion, the President asked for a motion to adjourn.

Shirley Mueller made a motion to adjourn, Sam Datello seconded. Motion passed by voice vote.

Meeting adjourned at 10:00 PM.

The regular meeting of the Wheeling Historical Society was called to order at 8:15 PM on Wednesday, April 23, 1980. President Buerger led the thirteen members present in the pledge of allegiance to the flag.

President Buerger asked for a motion to approve the minutes. There was a question from the floor -- Cris Irmiter noted Item E, page 2, line 22 of the minutes, in which it states that Park District is owner of the possessions of the historical artifacts. Matter will be investigated. Upon receipt of this advice, confirmation of the correction will be noted. The President read his copy of the Agreement between the Historical Society and the Park District, and discovered that his copy does not agree with Sam Dattilo's copy. Discussion ensued. Mrs. Irmiter made a motion to let the record show that the historical artifacts housed in the museum and various other areas are the possessions and property of the Wheeling Historical Society. Alberta Klocke seconded. Motion passed by voice vote. The minutes stand as corrected. Motion made by Mrs. Irmiter to approve minutes with the correction. Mrs. Klocke seconded. Motion passed by voice vote.

The Society was advised that the Brat and Beer is lost to the members. The Park District will assume responsibility again this year. Discussion ensued. Eleanore Buerger asked what fund raisers were available to equal the Brat & Beer. Comment was made that the current bank balance would prohibit the expense of such a project at this time. Glen Benson asked if funds were made available again to consider making field trips as a group.

ANNOUNCEMENT - The President read an announcement that on April 26, Arbor Day, the Park District will be planting rose bushes and trees at Chamber Park. Historical Society is invited to join this project at noon on Saturday. The event will be covered by the media.

B, Village Hall Complex (April 24) resulted in the President appointing Alberta Klocke, Cris Irmiter and Judy Abruscato to represent the Society. They will attend and report back. Mrs. Abruscato asked about a bake booth; Sam Dattilo asked if a float could be entered in the parade. Discussion ensued.
- Announcement of a seminar, April 26, given by the Congress of Illinois Historical Societies and Museums.

TREASURERS REPORT - (Attached)

Ed Klocke asked if the Treasurer could show the various balances in her report. Alberta Klocke made a motion to have the President direct the Treasurer to show a break down in her next report of the balances of each of the

allocated funds. This would show the balances in the Childerley and the Museum accounts and would reflect the total of the Society's operating fund. Tom Kavanagh seconded. Motion passed by voice vote. The Treasurer will be so directed.

Sam Dattilo asked what the Childerley fund covered. Gene Kavanagh advised it covered the log cabin, chapel and library, as far as she knew. This being the case, Alberta Klocke asked if work could be started on the stripping and restoring of the 13 kneelers now stored at St. Joan's house. This met with unanimous agreement. Comment was made that St. Joan's house will soon be ready, for children to be running in and about. Gene Kavanagh, Chairman of the Childerley Committee asked for quidance on how best to spend Childerley funds. She felt it had better potential than an 'outdoor gymnasium'. All of Wheeling parks are geared to play, etc. areas, and it was the hope of the Society to have an adult grounds for meetings, meditation and more spiritual activities. She felt the Society was investing in preserving historical and religious moments and that physical activities on these hallowed grounds would be sacrilegious. President Buerger asked Chairman of the Liaison Committee Sam Dattilo to call a meeting with Park District Liaison to inquire Society's position insofar as the preservation of this historic ground, further to find out if Park District will advise the Society what they are doing before unnecessary funds and time is spent on the log cabin. An example, pointed out by the President is the monies pledged to the tree project. Gene Kavanagh agreed that she would expect adopted trees and the orchard be spared from sports activities and general physical abuse and that she would recall her pledge based on Park District's intention. While there is no question of ownership; it is the feeling of the Society that we be informed before changes take place and perhaps be given the opportunity for some input. A liaison meeting will be planned.

May 28. She read the menu and announced the dinners will
cost \$10.25 per person. She advised a letter will be sent
to members advising time, etc. Mrs. Abruscato asked if
Chevy Chase personnel will be responsible for housekeeping
tasks. Mrs. Klocke said all work would be done by the Chevy
people. Dinner will be served in the Wayside Room; however,
there will be an open cash bar in the Gable Room (to save
cost of bartender).

#### UNFINISHED BUSINESS -

Election of slate of new officers.... President Buerger asked for a nomination from the floor; there were none. Alberta Klocke moved to elect slate as nominated by Nomination Committee (Glen Benson, Sam Dattilo and Alberta Klocke). Cris Irmiter seconded. Motion passed. Mrs. Irmiter made a motion to close nominations. Mrs. Klocke seconded. Motion passed. Mrs. Klocke made a motion to suspend the by-laws by having one ballot for all offices. Marshall Balling seconded. Motion passed. New officers are as follows: Ed Klocke, President, Gene Kavanagh, Vice President; Judy Abruscato, Secretary; Cris Irmiter, Curator; Glen Benson, Director. The new officers will take office at the Annual Installation Dinner in May. Mrs. Klocke asked if Sister Brigitte (member) be honored guest at the dinner. Tom Kavanagh made a motion to invite Sister Brigitte to the Installation Dinner as guest of honor. Judy Abruscato seconded. Motion passed.

- 2. President Buerger reminded members that every Monday, volunteers are asked to help prepare the Museum for its opening. ## MINUTES OF THE MEETING OF THE WHEELING HISTORICAL SOCIETY HELD MAY 28, 1980

The annual meeting was held May 28, 1980 with President Bob Buerger presiding. He stated he would like to thank Irene Dattilo and presented her with a rose for all she has done for the society. He also thanked Alberta Klocke for the work she had done in preparation of the dinner and the things she has helped us with in the past.

He advised those who were in attendance for the rededication of the historical museum, that we had a very good turn out. Sam and he did not get out of the museum until 1 p.m. This goes to show you that there are people in our community who are interested in knowing about the history of Wheeling. It is up to us to get that history and providing them with the information which they seek. He thanked Marshall Balling for putting the two pictures on the bathroom doors to let you know who the boss is on one side and men on the other. He did a fine job of painting the pictures. On the serious side, he stated they want to make the museum so the people of our community will be proud.

He then introduced the invited guests, Sister Bridget and Sister Michael and thanked them for being present.

President Buerger noted the members have been presented with the minutes of April 23, 1980 and requested they be approved. Alberta Klocke noted there was corrections. Motion was made by Wally, the minutes as written with the corrections made be approved. Seconded by Alberta. Motion Carried.

He stated it has been noted that the society records indicate that formal action has to be taken to increase the Liaison Board by two members. A motion was made to extend the wording of five members to the Liaison Board, to read from five to seven members and one member at large. Motion was seconded. Carried by Voice Vote.

He noted under Old Business, the subject of Brat and Beer. He read to the members what had been previously agreed upon and stated the society would receive a bigger percentage this year. Ed Klocke noted last year the percentage was 25% to the society and he now recommends the society go to the park board and request 40%.

He felt if the whole society got behind it, there would be no problem. Discussion ensued. Bob asked for volunteers to work at this years Brat and Beer and stated the Liaison Board would meet with the Park District and negotiate the amount of money that the society would be received. Discussion ensued. President Buerger noted the park is looking for the support of the Historical Society. Following lengthly discussion, Bob asked if the membership would work with the park district with a 40% cut. A show of hands indicated the members are willing to work with the park district on the Brat and Beer and instructed the Liaison Board to nogotiate on 40%.

On the 4th of July a float was discussed. Some of the members thought of putting the fire apparatus on the flat bed under the slogan of "People helping People". We have other antique equipment that would go with it, but we need the support of the members. He also made mention of having a booth but said he hadn't heard as yet. The members told him they would serve coffee, donuts, popcorn and taffy apples but volunteers are needed from 12:30 to 9 p.m.

Sam Dattilo reported he is negotiating on a fire truck which they would place beside the historical building if it is donated to the society. It was agreed that Sam should be given gas money as he has been driving all over the county. Charlie made a motion and it was seconded that Sam be reimbursed for gas money. Sam stated he would submitt receipts. Carried by Voice Vote.

President Buerger advised a motion was made and seconded to dispense with the rest of the meeting and introduced the new board. Motion carried.

Bob then presented the new Board for 1980-81

President .. Ed Klocke Vice President .. Gene Kavanagh Treasurer .. Dorothy Floentge Secretary .. Judy Abruscato

President Klocke took his chair and advised the business portion of this meeting has been adjourned and introduced the Society Historian, Marshall Balling.

Marshall Balling stated he was going to give a speech in two parts..the first the history of the DesPlaines River

Valley and the second, the role of Wheeling in the Yukon Gold Rush. He stated if he can do that in ten minutes, I would certainly like to get a prize. Before he went on, he thanked the members for giving him a chance to get to become interested in history. In school and college he never took a course unless it was required in history and never had the faintest desire to become a historian, and now that he is retired, giving him the honor of being an historian is a very great thing to him because when he does research, he finds his life is enhanced by this and he wishes our society could have that same role in their hearts not only here, but in our schools and in our town at large. He noted some years ago I had the occasion in Libertyville, when we were discussing oil paintings, I said I was from Wheeling and they said that was a cutural wasteland. I believe that may have been true and it could be true if it was not for us people to promote a reverance and a knowledge of the past but our society is so damable to this sort of thing that I want to pay tribute to formation of this society. I'm glad John Koeppen is here tonight cause I know that the I'm sure it was the National Association of Women's Clubs, speaking not of John but of his lovely wife, offered a prize or credits if you started a historical society. The Wheeling Women's Club decided to do that and between Shirley and John, our society was initiated. I certainly thank them for this. /

As you know, Wheeling is an entity on the outskirts of Chicago. Many of us are new here and there is a realization of the untold stories we have here. It's unbelievable when you go into the history of any area, of the avenues that open themselves up. I am thrilled that not only Father Marquette, but LaSalle passed through our area in the earliest desire of the French to find out how they could increase their power in the middle west and of course the Priest wanted to increase the power of God and religion among the savages. Our early history is innertwines more with the French than with anyone else. The French in Quebec is given credit for traveling the five great lakes, and then they said through their conversations with the Indians that legally there is a route to China through the Great Lakes, the Governor General of Canada said there will be great reward for anyone that finds that path through the Great Lakes and a short route to China.

They took their canoes and came down through Sioux St. Marie in the green bay and the indians said yes there is a great

River. They traveled down the Fox River near Lake Winnebago into the Wolf River and down to the head waters near Portage Wisconsin. There they portaged over to the Wisconsin River and then into the Praire DuSien down the Mississippi to the Illinois River. They came up the Illinois River feeling that there was some closer route so Marquette on his first visit came up the Illinois River and came into the Chicago area and found that the Chicago River was nothing so they portaged over to the DesPlaines River. They called it the "Devine River". It was also known as the St. Louis River and they traveled up the DesPlaines River went through Lake County and where DesPlaines River comes close to Waukegan. They found a little creek up in Gurnee and they portaged over to Waukegan, got to the lake and paddled back to Quebec, so our DesPlaines River became a vehicle for the opening of the midwest. They didn't get down the Mississippi to find a way to China because the indians down there were too hostile and they turned back. Eventually Father Marquette who was very ill, when he got to Lovington Michigan, died.

Marshall stated he found this very interesting that our river was that important. He stated he could not believe the river was ever deep enough for canoes laden with supplies and men to be traveled, so research shows yes they said only in the spring, when the flood waters were heavy and the river would be triversed far up as Waukegan, but in the winter time when the river was frozen, it was a boulvard. There were indian trails along side the river but he did not think Marquette and his group would use those trails. He is sure they would have used the winter to travel plus the fact that the winter ice would be very easy for the dog sleds and etc.

Marshall noted that anytime you go pass the river, where he was raised, yet behind this is the poetic concept of the government of Canada and France coming down our little stream trying to find a way to China or to try to develop the middle west. He noted it's a wonderful thought.

As far as the gold rush, Marshall stated, I can't think that Wheeling was a one time, a very desirable place to to claim homesteading. In 1834 there was a land rush and people were coming out here to homestead. Now the history which he has, said there was a treaty with the indians in

September of 1833 and at that moment the indians had nothing

more to say and had to leave. Other accounts said 1821 and 1829, so it appears that negotiations were going on. The state of Illinois was founded in 1818 and the Fort Dearborn massacre occurred in 1812 and Chicago was a city, yet our area here was still owned by the indians. Chicago was part of Peoria County and before that it was part of the state of Virginia. This was the northwest territory and the governor of Virgina had the state which was called Brown County (from Indiana to Wisconsin and Minnesota and parts of Iowa), so these negotiations were going on but apparently in 1833 this area became open to the white men. We had a land rush and the nearest court was in Chicago. Its unbelievable that progress came through the south part of Cook County. People just passed through here and Waukegan was the site of the huge trading post and they built a little fort there. The name "Little Fort" still occurs in Waukegan and thats the reason that the Jesuits, Marquette and those men established a trading post there.

Marshall gave a brief account of the Yukon gold rush. Gold was known up in the Yukon territory for many centurys but there was a gold find in California and there was gold in South America and nobody wanted to go to that area to look for gold until an Illinois man named George Karnack wemt fishing in a stream called Bonanza Creek. He saw a sand bar and something glittering in it, so he went home got a pan, picks and shovels and returned to the creek and in a few days he found thirteen hundred dollars worth of gold. So the word bonanza came right from there in 1889, when this word got out everybody wanted to go to the Yukon and hunt for gold. The Canadian government had a railroad called the Canadian Pacific that went from coast to coast to Edmond, which seemed to be the jumping off place for the Yukon. and the Sioux St. Marie railroad (our railroad is shown on the early maps from Minneapolis to Moose Jaw Canada and Edmond). It don't show the Sious Line into Chicago but apparently the people got to the twin cities and then took the Sious line to get up into Canada and Edmond. Many men did not make it. The common way was to take a ship from Seattle to Skagway go over the rockie mountains to Dawson City which was right where the Bonanza Creek was, but that was very difficult to get over the passes. The other way the river route was to go up to Lake Absaka to the artic circle and then to come back. That was the Canadian route. There are stories about men who got caught in the bad weather and never made it.

Wheeling, years ago in the 1930's, had a character by the name of Red Mary who was a dance hall girl from the Yukon Gold, started a nightclub and tavern in Wheeling right where the new bank is at this time. He remembers her very well, unfortunately he was so nieve, that he never got one single tale out of this woman. Basically how this girl ever got to Dawson City is a mystery to me. She must have taken the boat and because there were dance halls, they would get the money away from the miners (who had more money than they knew what to do with), and this woman for some reason, it must have been 1917 because probition came in in 1920 and I know that her place was raided and closed up a number of times. It was an old tavern on the corner where Shannon's Filling Station was that she moved back down near the river put a huge porch on it and called it the Wheeling Inn. She beautifully landscaped grounds and had a full fledged nightclub, with a orchastra, colored maids. In 1920, I presume she ran afoul of the law and her business gradually became less and less so she bought a Sears Robuck house and erected it on the back of the property which became a hide away for people. This building was put up as a place with many bedrooms. Her life added a certain character to the life of Wheeling. Wheeling always was a tavern town and at one time there were seventeen liquor licenses when the population was only 300 and in her later days, (I knew this lady, her name was Mary Harper), and she was a small blonde and in her later days she was destine. She would call me at the bank and told me to pick up her deposit. It was sad in her later years she still served food but no body would come. She fitted into the character of Wheeling to a great extent.

Marshall appologized he does not have more stories that could approximated the Yukon Gold Rush. It would be wonderful if we had a heritage of stories in Wheeling. He is still trying to remember them about farmers and cattlemen as Wheeling was of course a dairy town. There were two or three creameries in Wheeling. I live on the side of one and blacksmith shops. My grandfather was a blacksmith and in the museum we have a thing which the harness makers sat on and made their bridles etc. The character of our past is so that I feel we should be proud of it. Everything happens by chance (nobody saids we are going to build a village here). I'm sure our village is named after Wheeling West Virginia because I find now that so many midwestern towns were named

after New York cities any number of them were named because people came from New York to the midwest to build a new life and they brought the names with them.

I was reading a brochure on Warren Township which is the city of Gurnee and they traced the name of Warren Township to General Joseph Warren who was a Civil War general. Why they ever picked him, no one knows or will ever know. The other night I was to a quite precedious luncheon asked all of the Wheeling Township officials who were present if they were a little squimsh about calling everything Wheeling Township. He advised them that Wheeling is older than Arlington Heights older than Mt. Prospect and the reason being that progress follows the river. People from Chicago came out the DesPlaines River as did Marquette and LaSalle did, and Milwaukee Avenue was built on an indian path to go up toward Milwaukee. I understand the first post road was Milwaukee Avenue and a french canadian named Juno was the first contract to deliver mail. Another account said claimed a man walked from Detroit to Chicago once a month five hundred miles to deliver mail.

To show about people who have theories, one historian printed in his brochure on the history of Warren Township because I knew Wheeling was inbetween here and Gurnee and that their history was our history only we were a couple of years ahead of them. Our Captain Wright was monumented up here in 1836. Wheeling had records of people living here in 1834. The first white permanent settler came here in 1833. It's strange to find how primative we were when the city of Chicago was quite well established but character of the roads and country, there wasn't much travel into the city.

I would like to say before I sit down that one of our projects would be is to make ourselves to the high school history classes and ask the teachers if they could perhaps encourage the children to become interested in the history of Wheeling, and if we could give small prizes for essays about the past. I feel the more we look into the past, the deeper our present is and we are in the front line in the culture of Wheeling and add depths of Wheeling.

Sam questioned if there was any truth that Wheeling wanted to annex to the city of Chicago? Marshall stated he had never heard of this and felt it wouldn't be possible. He was under the impression that the name Wheeling was derived from an indian word meaning "Village by the River" and accepted that, but now that he is doing research, he feels our name has come from the east. People didn't have the imagination to come up with names by themselves. Wheeling West Virginia derives from the name "Village of the Head". It seems that a massacre there and someone in retaliation, murdered an indian and stuck his head on a staff and that place was known as "the place of the head" and the indian name derived was roughly Wheeling. It is his feeling that is where we got our name.

#### Adjounment

There being no further business, the meeting concluded at at 9:27 p.m.

## WHEELING HISTORICAL SOCIETY MINUTES OF 6/25/80

The meeting of the Wheeling Historical Society was called to order by President, Edward Klocke at 8:15p.m. with pledge of allegiance to the flag. Mr Klocke thanked those present for attending the meeting.

Since the May meeting was our installation dinner-meeting there were no minutes taken.

\$288.71 from Brat and Beer last year remains in the Park District Treasury. This amount has been ear-marked for restoration of Childerly. Let the record reflect that the amount of \$288.71 remains in the Park District Historical Account, to be used as needed for the restoration of Childerly.

Sam Datillo thought the money should be given to Historical Society from the Park. Mr. Klocke stated the money was there to be used at anytime the Historical Society decided to start the restoration on the Chapel at Childerly. Mr. Powers inquired as to whether or not we were receiving interest on the money. In answer to his question Mr. Klocke stated that the money was not being kept in a savings account, so therefore, there would be no interest. Mr. Benson moved to approve the Treasurers Report seconded by Mrs. Mueller. After a lengthy discussion the report was approved by those members present.

Mr. Klocke suggested in the future agendas be mailed to each member of Historical Society so that they will be aware of what would be discussed at the next months meeting. We will sell popcorn, donuts, coffee and taffy apples in the booth. The apples are being donated by the Addolorato Villa.

The Christmas gifts for the Villa were discussed, a ceramic ring box and jewerly box are being made by Mrs. Klocke. Mr. Klocke asked for a \$75,00 donation from Historical Society for this project. Discussion ensued. A motion was made and seconded to donate \$75.00 for the making of the gifts for the Villa. Motion carried.

The regular meeting of the Wheeling Historical Society opened at 8:05 PM on Wednesday, August 27th at the Old Church, Chamber Park. Acting President Gene Kavanagh led the members in the pledge of allegiance to the flag. The President, Ed Klocke, is away on vacation.

Members were asked to sign the log journal and pick up a copy of the agenda.

Mrs. Kavanagh thanked the members for attending. In her address, she opened the discussion of a field trip for the members. Historic sites were discussed and Galena appeared to be the most popular. Mr. Datello advised also that the Historical Society's 40% came to \$1500 approximately. Mrs. Claire Rudolph was disappointed when she was told she could not purchase brats after close of the fest. D. Phillips advised all left-over brats were going to the Villa. Mr. Datello said that last year, cooked brats were delivered to the Villa, but uncooked brats remained at Chevy Chase. However, he said this year, they were being sold. No one is certain how these brats were dispensed. Mr. Rudolph asked if the Society would get 40% of those sales.

- A) Mrs. Kavanagh asked for a motion to table this item (Legality of Society/Park District Agreement) as research is not yet completed. Motion made by Mr. Buerger, seconded by Mrs. Irmiter. Motion passed by voice vote.
- B) Not for Profit Annual Report Form -- Mrs. Rudolph said a form of this nature was received at the Forke house; she advised them to send it to Ed Klocke. She will call to see if this was done, as the form must be immediately submitted to Springfield. Discussion ensued.
- C) Minutes of Meetings covering May June and July were never submitted to the Board. Mr. Buerger asked if the Board had received Mrs. Abruscato's resignation. Mrs. Kavanagh advised she was not notified. Mr. Buerger was asked to contact Mrs. Abruscato and inquire her position at this time and to have her return the Book of Minutes.

Discussion ensued regarding breakdown of budget which defines this expense. Mr. Tom Kavanagh pointed out that trees and ornaments need to be replaced; and a new Santa Claus suit was mentioned. # AMENDED AGREEMENT BY AND BETWEEN WHEELING PARK DISTRICT AND WHEELING HISTORICAL SOCIETY

THIS AGREEMENT made this 16 day of July , 1981 in amendment of the October 7,1976 agreement, by and between WHEELING PARK DISTRICT, Cook and Lake Counties, Illinois, (referred to herein as "Park District"), an Illinois unit of local government, and WHEELING HISTORICAL SOCIETY, Cook County, Illinois, (referred to herein as "Society"), an Illinois not-for-profit corporation.

#### WITHNESSETH:

WHEREAS, Society has determined that it is in the best interests of the residents of the Wheeling area to preserve those historical artifacts which it owns or will acquire and which would be of lasting benefit to the residents of the Wheeling Area; and

WHEREAS, Park District has determined that it is in the best interests of the residents of the Wheeling Park District that certain premises located within the boundaries of the Park District be designated and operated as museums pursuant to the authority conferred by Section 8-3 and 326 of the Park District Code; and

WHEREAS, under and by virtue of Section 10 of Article VII of the Illinois Constitution of 1970, local government units within the State of Illinois are authorized to enter into Interlocal Agreements providing, among other things, for the exercise, combination or transfer of any power or function in any manner not prohibited by law or ordinance, and for the use of their credit, revenues, and other resources to pay costs related to intergovernmental activities; and

WHEREAS, the Park District desires to provide for the payment annually from the Historical Fund tax revenues of the Park District the cost of improving and maintaining the historical properties, including but not limited to, the cost of all repairs, utilities, services, insurance on artifacts and structures (including contents), and custodial services.

NOW THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, the parties hereto do agree as follows:

Section 1: Park District agrees:

(a) That it will acquire and maintain park district

buildings and facilities of historical significance for use by the general public.

- (b) That it will appropriate and levy needed funds for the operation, maintenance and improvement of sites which have been designated as museums.
- (c) That it may, with Society approval, retain a staff person whose duties would be mutually agreed upon by the parties.
- (d) That it shall during the annual budget deliberations, consider the input of the Society in the allocation of financial resources derived from the Historical Fund tax levy pursuant to Section 2(b) of this Agreement.

#### Section 2: Society Agrees:

- (a) That it will continue to raise funds to assist in the payment of expenses of the Society and adopt an annual budget to be approved by the Society membership.
- (b) That it will submit not later than November 30th of each year, to the Park District's Superintendent of Parks and Recreation, a proposed Park District Historical Fund budget for the Fiscal Year January 1 to December 31. This proposed budget shall recommend how the Historical Fund tax receipts budgeted to be collected in the Fiscal Year, be allocated. The Society's proposed Park District Historical Fund budget shall include the detailed justifications necessary to support the proposals of the Society.
- (c) That it will provide the expertise necessary in determining buildings and historical material to be acquired by Park District and Society.
- (d) That upon any dissolution of the Wheeling Historical Society, it will transfer title to its artifacts, assets and other personal property to the nearest museum.
- Section 3: It is further agreed that a Liaison Board will be maintained consisting of three Society Members and three Park Commissioners. Liaison Board Members shall be appointed annually by the President of the Society and the Park District and shall serve until their successors have been chosen.

The Liaison Board shall have the authority to choose a Chairperson, Vice-Chairperson and other such officers as appropriate and set times for at the minimum, quarterly meetings to be held in February, May, August and November of each year.

The Liaison Board shall develop and recommend to the Park District Board and the Society membership policies to be adopted pertaining to the implementation of this agreement, which when approved by the Society membership and Park District Board shall be the policies governing the Liaison Board.

Section 4: The terms of this Agreement may be altered or amended by the concent of the parties hereto.
